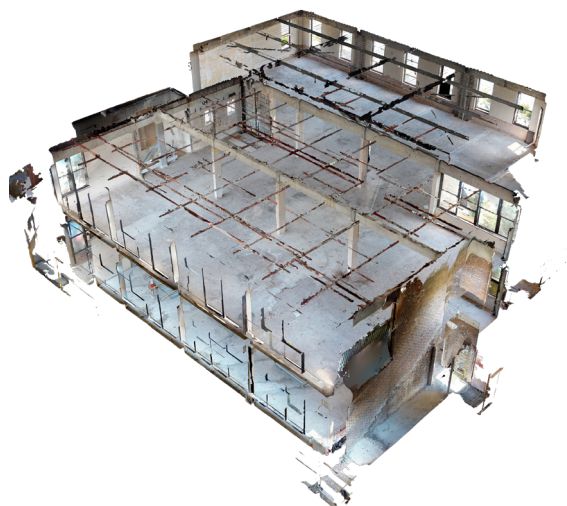
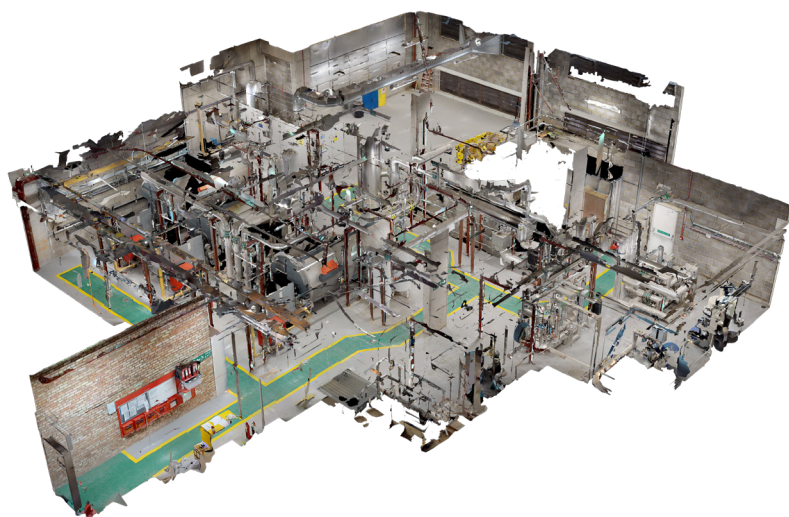

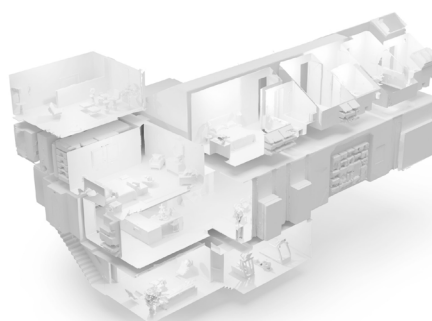

You are known as the 'responsible person'. If there's more than one responsible person, you have to work together to meet your responsibilities.





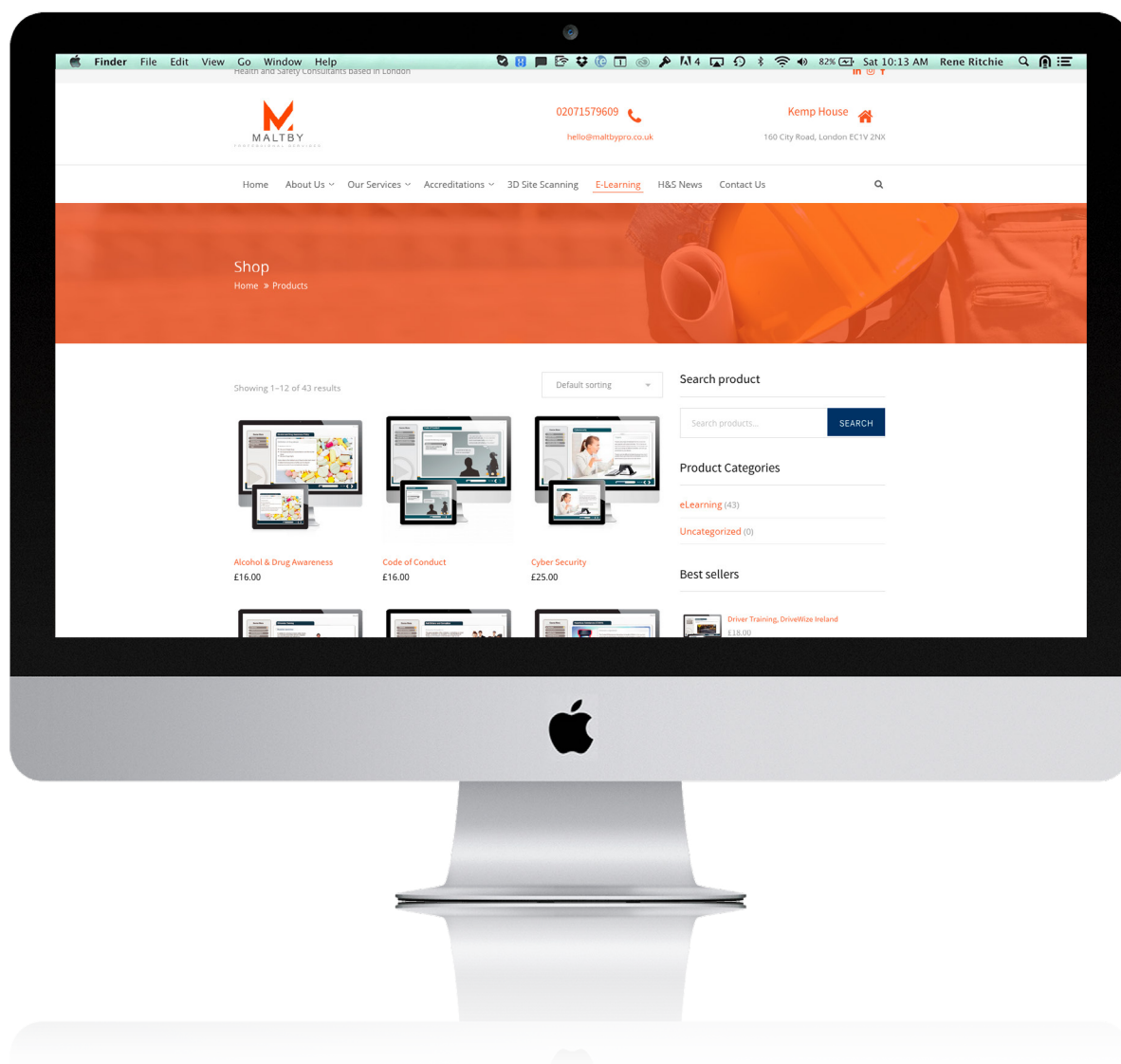
